## Application for Arkansas Broker's License Experience Requirement

As an applicant for original licensure as a broker, you must demonstrate that you have met the experience requirements set forth in Commission Regulation 4.1(3). The guidelines for submitting said demonstration are provided for in Regulation 4.1(a)(3)(A) and are as follows:

“...documentation as the Commission deems satisfactory to demonstrate that the applicant has gained experience in the real estate business equal to that which would be gained by a person engaged in the real estate business on a full time basis during a minimum two year period of time; Listings, sales or other licensed activities may be considered by the commission in determining whether the applicant meets this qualification; Consideration shall be given to the broker applicant's local real estate market and/or specialized area of real estate practice. Any person whose application for broker license is denied by the executive director may appeal such denial to the Commission provided the request for appeal is in writing and received in the office of the Commission not later than sixty (60) days following the date of denial by the executive director.”
